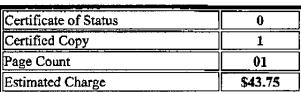

### ARTICLES OF AMENDMENT

# TO THE ARTICLES OF INCORPORATION

OF

### CNL PROPERTIES CORP.
