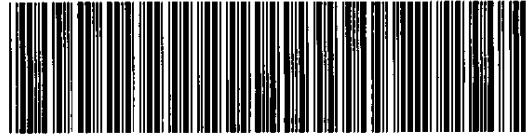



ARTICLE I. NAME

The name of this corporation is J & B MAINTENANCE INC.

ARTICLE II. DURATION

This corporation shall have perpetual existence.


