ARTICLES OF AMENDMENT

TO

ARTICLES OF INCORPORATION

OF

MEDMAL DIRECT INSURANCE COMPANY

Pursuant to the provisions of Section 607.1006, Florida Statutes, MEDMAL DIRECT INSURANCE COMPANY adopts the following Articles of Amendment to its Articles of Incorporation:

ARTICLE IV.

CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to issue is 10,000,000 shares of common stock, having a par value of \$0.50 per share. The common shares shall have unlimited voting rights, with each share being entitled to one vote, and the right to receive the net assets of the corporation upon dissolution, with each share participating on a pro rata basis. The corporation's capital and surplus shall be not less than the amount required under Florida law.

This amendment is adopted as of March 14, 2013.
