

Pursuant to the provisions of Section 607.1006, Florida Statutes, MEDMAL DIRECT INSURANCE COMPANY adopts the following Articles of Amendment to its Articles of Incorporation:

ARTICLE IV.

CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to issue is 10,000,000 shares of common stock, having a par value of \$1.00 per share.
