The undersigned Incorporator hereby files these Articles of Incorporation in order to form a SA Corporation under the laws of the State of Florida.

Article 1. Name and Principal Office

The name of this Corporation shall be **YOU'RE COVERED WARRANTY CORPORATION.** The principal place of business and mailing address of this Corporation shall be 2755 West Tennessee Street, Tallahassee, Florida 32304-2839.

Article 2. Nature of Business

The general nature of the business and activities to be transacted and carried on by this Corporation are to engage in the issuance of motor vehicle service agreements pursuant to Chapter 634, Florida Statutes, and in any other activity or business permitted under the laws of the United States of America and the State of Florida.
