ARTICLE I Name of Corporation

The name of this corporation is RIBO INC.

ARTICLE II Purpose

Organized primarily as a retailer of cosmetics and other household goods, RIBO INC. will, with the approval of its Board, transact any and all lawful business permitted under the laws of the United States and the State of Florida.

ARTICLE III Capital Stock

Initially, this Corporation is authorized to issue 10,000 shares of common stock at \$0.01 dollar par value.

ARTICLE IV <u>Corporate existence and Date of Operation</u>
