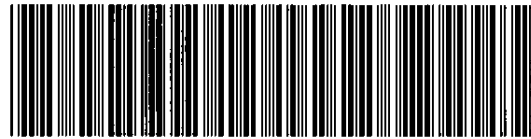




Whereas, Assignor has not contributed any capital or other value to the Corporation.


Whereas, Assignor holds no ownership or equity interest in the Corporation and has never held any ownership or equity interest in the Corporation.
