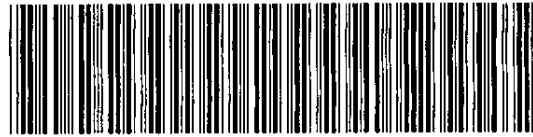


ARTICLE IX


