**PREAMBLE** 

Effective Date

The Registered Agent for this Corporation shall be **Barbara J. When not prohibited by law, any action of the shareholders of this Corporation may be taken without a meeting if consent, in writing, setting forth the action so taken, shall be signed by all the persons who would be entitled to vote upon such action at a meeting and filed with the secretary of the Corporation as part of the corporate records.
