ARTICLES OF INCORPORATION

The undersigned, acting as Incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation of such Corporation:

**ARTICLE I
NAME**

This Corporation shall exist perpetually, unless sooner dissolved according to law.
