The undersigned for the purposes of forming a professional service corporation for pecuniary profit under the provisions of Chapters 607 or 621, Florida Statutes, hereby makes, subscribes, acknowledges and files the following Articles of Incorporation:

**ARTICLE I. NAME**

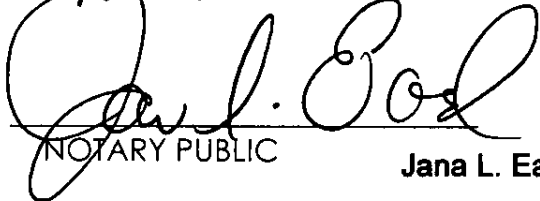

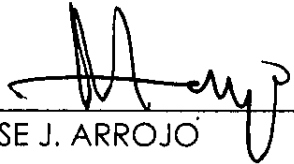
