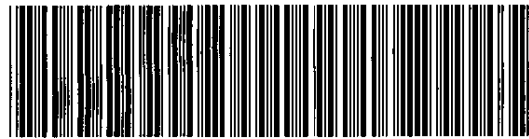

The undersigned, acting as incorporator of **TRUSTWORTHY TRUCKING III, INC.** under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

**ARTICLE I. NAME**

The name of the corporation is **TRUSTWORTHY TRUCKING III, INC.**

**ARTICLE II. ADDRESS**

The existence of the corporation will commence upon the filing of these articles of incorporation.

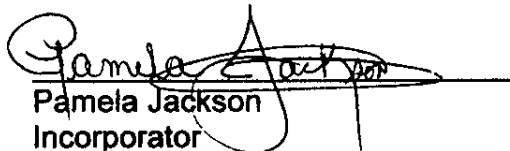
## ARTICLE VIII. BYLAWS

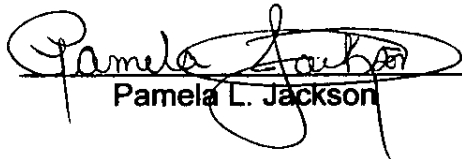
