

ARTICLES OF INCORPORATION OF MELISSA EMS INSURANCE AGENCY, INC.



ARTICLE I. NAME

The name of this corporation shall be Melissa Ems Insurance Agency, Inc.

ARTICLE II. COMMENCEMENT & DURATION

The commencement of this corporation's existence shall be at the time of the filing of these Articles Of Incorporation by the Secretary of State. This corporation's duration shall be perpetual.


