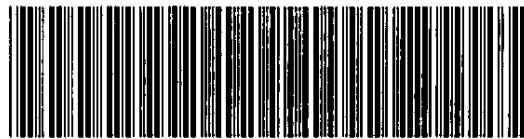

ARTICLE I.


