**ARTICLES OF INCORPORATION
OF

THE UNDERSIGNED incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

FIRST: The name of the corporation is **ADVANCED TRADING COMPANY INTERNATIONAL, INC.** (the "**Corporation**").


