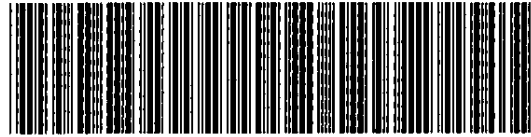

**ARTICLE IV**

**PURPOSE and POWERS**

The purpose for which the corporation is organized is to engage in the business specializing in cost effective service and delivery of small-package shipping. Also offering business to business delivery and convenient residential service through contracted service with Fed Ex., to own operate and lease trucks that will also provide delivery services for Fed Ex. Doing business with and for government entities, private and public business merchants. Bidding on Government contracts, partnerships, and competing for community block grants, awards and entrepreneurial opportunities for profit and non-profit ventures. Networking with larger companies on jobs that utilize operators of leasing trucks for delivery and freight services. 5. Any officer who does not carry out his/her fiduciary duties, relating to payment of company taxes and expenses.
