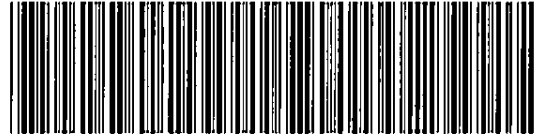

Article IV - Capital Stock: Number of Shares

The Corporation is authorized to issue Sixty Thousand (60,000) shares of common stock One Dollar (\$1.00) par value per share, which shall be designated "Common Shares."
