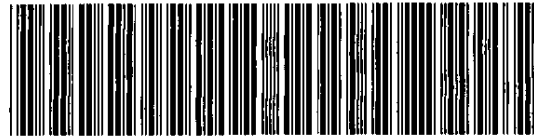

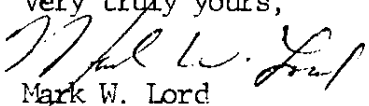

I, the undersigned, do hereby submit these corporate articles to establish the referenced entity as a corporation for profit under Florida law.

ARTICLE I

The name of the corporation is: MATICO, INC..

ARTICLE II

The corporation shall have perpetual existence.

ARTICLE III

This corporation is organized to conduct and engage in all business enterprises, including but not limited to: creating, servicing, and collecting mortgages on residential and commercial real estate; providing, servicing, and/or collecting unsecured loans, notes, and other contracts of indebtedness; acquiring and managing all types of assets, including businesses and residential and commercial real estate; and providing funding and financing for the purchase and acquisition of real estate, ongoing business enterprises, and other assets.

ARTICLE IV

The aggregate number of shares of stock which this corporation is authorized to issue is Ten Thousand (10,000), all of which shall be common shares with a par value of One Dollar (\$1.00) per share. Each shareholder has full preemptive rights to purchase shares held or owned by other shareholders of the corporation. The business affairs of the corporation shall be managed by the Shareholders.

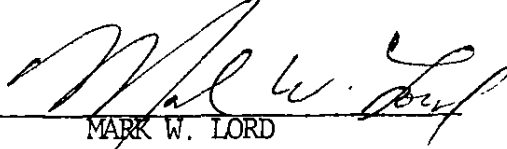
