



ARTICLE I.

NAME

The name of this corporation is Trident - Boca, Inc.

ARTICLE II.

PRINCIPAL OFFICE

The principal office and mailing address of this corporation is 1022 Main Street, Suite Q, Dunedin, Florida 34698.

ARTICLE III.

DURATION; EFFECTIVE DATE

This corporation shall exist perpetually, commencing as of June 29, 2010.

ARTICLE IV.

PURPOSES

This corporation may engage in any activity or business permitted under the laws of the United States of America and of this State.

ARTICLE V.

CAPITAL STOCK

This corporation is authorized to issue Ten Thousand (10,000) shares of \$1.00 par value common stock.
