ARTICLE I.

NAME

The name of this corporation is Trident - Parkersburg, Inc.

ARTICLE II.

PRINCIPAL OFFICE

The principal office and mailing address of this corporation is 1022 Main Street, Suite Q, Dunedin, Florida 34698.

ARTICLE III.

DURATION; EFFECTIVE DATE

This corporation shall exist perpetually, commencing as of June 29, 2010.

ARTICLE IV.
