ARTICLES OF INCORPORATION

In compliance with Chapter 607 and / or Chapter 621, F.S. (Profit)

Article I. Name

The name of the Corporation shall be Heccatoncara Corporation. The name derives from the Hecatonchires (heck-katin-kair-is) - giants from Greek mythology each having 100 hands and 50 heads. The word Hecatonchires is derived from the Greek words *hekatón* meaning "hundred" and *kheir* meaning "hand". As such the characters of the Hecatonchires symbolize the corporate intent to have hands in as many projects as possible. The Corporation is an S Corporation.

Article II. Principal Office

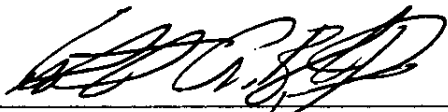

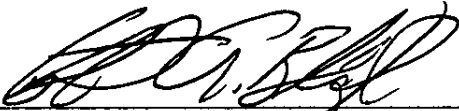
