ARTICLES OF INCORPORATION ACTIVE PROPERTY MANAGEMENT, INC.

Allahasan Andrew THE UNDERSIGNED incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

<u> ARTICLE I – Name</u>

The name of the corporation shall be ACTIVE PROPERTY MANAGEMENT, INC. (hereinafter referred to as "the corporation.").
