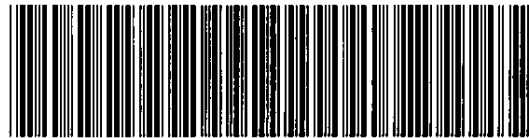

In compliance with the requirements of F.S. Chapter 607, the undersigned hereby act as incorporators in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

**ARTICLE I**

The name of the Corporation is: Government Integrated Solutions, Inc.

**ARTICLE II**

The purpose for which the Corporation is organized is to engage in any activity or business permitted under the laws of the United States and the State of Florida. The Corporation shall have a perpetual existence.

**ARTICLE III**

The street address of the principal office of the Corporation is: 3842 S. Hopkins Avenue, Titusville, Florida 32780.

**ARTICLE IV**

The maximum number of shares this Corporation is authorized to issue is one hundred (100) shares, all of which shall be Common Shares. All of the shares of stock of the Corporation may be subject to a Shareholders' Restrictive Agreement containing numerous restrictions on the rights of shareholders of the Corporation and transferability of the shares of stock of the Corporation. A copy of said Agreement is on file at the principal office of the Corporation. No super majority voting requirements exist for shareholders to approve corporate actions.

The initial board of directors shall consist of two members. This number may be

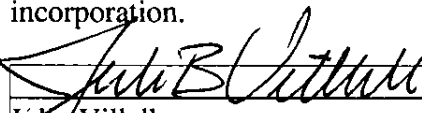
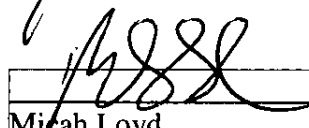

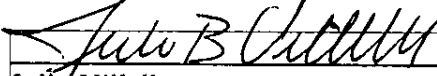
