The undersigned incorporator hereby executes these Articles of Incorporation for the purpose of forming a professional service corporation accordance with the laws of the State of Florida.

ARTICLE 1

NAME

The name of this corporation shall be: MUA ASSOCIATES OF WEST FLORIDA, P.A.

ARTICLE 2

PRINCIPAL OFFICE AND MAILING ADDRESS

The address of the principal office and the mailing address of this corporation shall be 430 MORTON PLANT STREET, SUITE 210, CLEARWATER FL 33756.

ARTICLE 3

CAPITAL STOCK

The total number of shares of capital stock authorized to be issued by this Corporation shall be 10,000 shares of common stock, par value \$.01 per share.

ARTICLE 4

REGISTERED OFFICE AND REGISTERED AGENT

**ARTICLE 7
PURPOSES AND DURATION**

The general purpose for which this corporation is organized is the transaction of any and all lawful business for which corporations may be incorporated under the Business Corporation Act of the State of Florida, and any amendments thereto, and, specifically, the practice of medicine as a professional association under Chapter 621, Florida Statutes. In connection therewith, this corporation shall have and may exercise any and all powers conferred from time to time by law upon corporations formed under such Act. This corporation shall have perpetual existence.

**ARTICLE 8
RENDITION OF PROFESSIONAL SERVICES**

The corporation shall render the professional services described in Article 7 only through its agents, officers, directors, employees, contractors, and representatives who are duly licensed or otherwise legally authorized in the State of Florida to practice medicine or osteopathic medicine or provide the ancillary medical, osteopathic, chiropractic, and therapy services requested. The term "agents," "officers," "employees," "contractors," and "representatives" shall not include clerks, secretaries, bookkeepers, technicians, and other assistants who are not usually and ordinarily considered by custom and practice to be rendering professional services to the public for which a license or other legal authorization is required.

**ARTICLE 9
BYLAWS**


The power to adopt the bylaws of this corporation, to alter, amend or repeal the bylaws, or to adopt new bylaws, shall be vested in the Board of Directors of this corporation.

**ARTICLE 10
AMENDMENT OF ARTICLES OF INCORPORATION**

This corporation reserves the right to amend, alter, change or repeal any provisions contained in these Articles of Incorporation in the manner now or hereafter prescribed by statute, and all rights conferred upon the stockholders herein are subject to this reservation.
