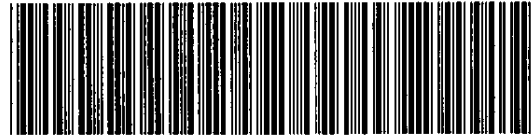

ARTICLE I: NAME

The name of this corporation shall be: AVIVA HEALTHCARE, INC.

ARTICLE II: DURATION

The period of this corporation's duration is perpetual.

ARTICLE III: PURPOSE

The purpose of the corporation is to engage in any or all lawful acts or activities for business permitted under the laws of the State of Florida.

ARTICLE IV: CAPITAL STOCK

The maximum number of shares of stock that this Corporation is authorized to issue is 1,000 shares of common stock.

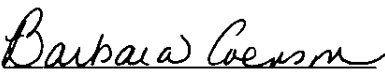
