

ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name and mailing address of this corporation shall be:

SUNSHINE CIGARETTE, CORP. 3470 S.W. 72 Old Avenue Miami Florida 33155

<u> ARTICLE II - DURATION</u>

This comporation is to exist perpetually. It shall commence its existence upon the signing of these Articles of Incomponation by the initial subscribers.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any and all business permitted under the laws of the United States of America and the laws of the State of Florida.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 500 (FIVE HUNDRED) shares \$1.00 (ONE DOLLAR) per value.
