ARTICLES OF INCORPORATION
OF SPEECH OUTREACH SERVICES, P.A.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Professional Service Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I
NAME

The name of the corporation shall be:

Speech Outreach Services, P.A.

ARTICLE II
PRINCIPAL OFFICE

To engage in speech – language pathology as defined in Florida Statutes §468.1125(7)(a) and as permitted under the laws of the United States and the State of Florida.

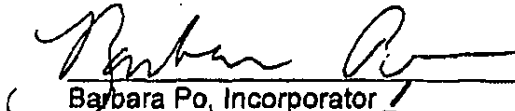
ARTICLE IX
