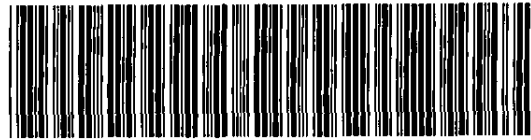

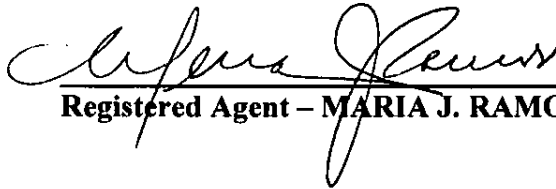

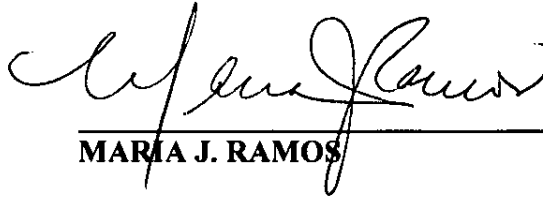
ARTICLE XII EFFECTIVE DATE
