# ARTICLES OF INCORPORATION OF AMBASSADOR ACQUISITION, INC.

The undersigned, acting as incorporator of a business corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation for such business corporation.

#### **ARTICLE I - CORPORATE NAME**

The name of the Corporation shall be:

AMBASSADOR ACQUISITION, INC. (the "Corporation").

#### ARTICLE II - PRINCIPAL OFFICE AND MAILING ADDRESS
