The corporation is authorized to issue 1,000 shares of common stock, which shall be designated as "Common Shares."

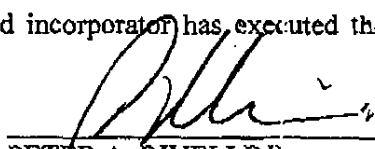
