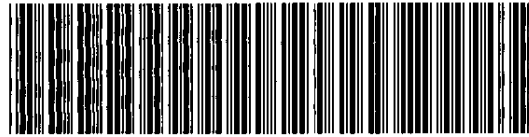

The undersigned, for the purpose of forming a corporation pursuant to the provisions of the Florida For – Profit Corporation Code hereby adopt the following.

Articles of Incorporation:

**ARTICLE 1:
(NAME & VISION STATEMENT)**

The name of the Corporation shall be Joyeous Productions, Inc. (referred to below as “The Corporation”). JOYEUS PRODUCTIONS, INC vision is that we will bring quality performing arts events that provide an uplifting experience and bring joy to the hearts of the Tampa Bay Community. 800 55th Avenue South St. Petersburg, Florida 33705

**ARTICLE 2:
(PROFIT)**

The Corporation has authority to issue not more than one hundred thousand (100,000) shares of common stock that together have unlimited voting rights and that together are entitled to receive the net asset of the corporation upon dissolution.
