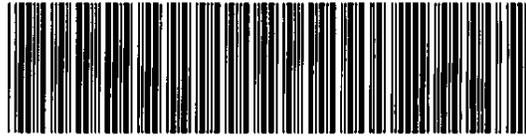

WHEREAS, on December 23, 2010, pursuant to Section 607.1402, Florida Statutes, Alyn Cruz Higgins, the sole Director and Shareholder of **ACH Fundraising Strategies, Inc.**, a corporation organized under the laws of the State of Florida on July 16, 2010 (the "Company") has determined that it was in the best interests of the Company to dissolve the Company;

WHEREAS, pursuant to Section 607.1402, Florida Statutes, the Company took valid action by Unanimous Written Consent of the Board of Directors and Shareholders of ACH Fundraising Strategies, Inc. approving dissolution of the Company;
