ARTICLE I.

NAME

The name of the Corporation shall be CERO IMPACTO, CORP.

ARTICLE II.

PRINCIPAL OFFICE

ARTICLE III.

PURPOSES

The purpose for which the corporation is formed and the business and objects to be carried on and promoted by it are as follows:
