The undersigned authorized representative of a member of the captioned For-Profit Corporation, under the provisions of the Florida Business Corporation Act, and pursuant to Chapter 607 or 621 F.S., does hereby adopt the following Articles of Incorporation for such corporation:

## ARTICLE ONE NAME

The name of the corporation is: Enasyn, Inc.

**ARTICLE SEVEN  
LIMITATION OF LIABILITY**

- (5) An act or omission for which the liability of a Director is expressly provided for by an applicable statute.

In addition to the limitation of liability set forth above, the liability of a Director to the corporation will be further eliminated or limited to the full extent permitted by any Florida or other applicable statute, as now existing or as may be amended.

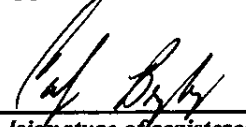
