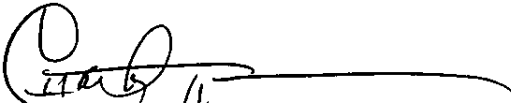

ARTICLE I

Name of Corporation

The name of this corporation is ESJ ELECTRIC INC.

ARTICLE II

Purpose

Organized primarily as a provider of electrical services, ESJ ELECTRIC INC. will, with the approval of its Board, transact any and all lawful business permitted under the laws of the United States and the State of Florida.

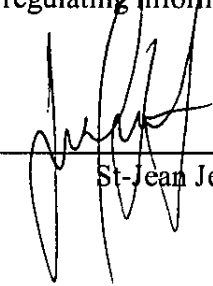
