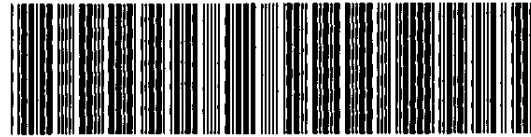

Preemptive Rights



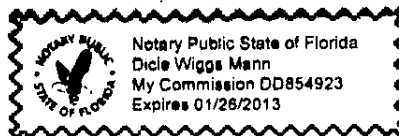


