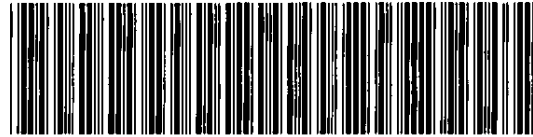

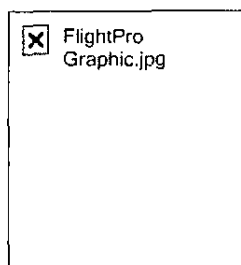

I have a couple of questions:

- 1) Having checked the entry for this company online at <http://tinyurl.com/sunbizflightpro> I note the FEI/EIN number is blank.

Please update the record with the correct FEI/EIN number as follows: 90-0588426

I attach a copy of our attorney's letter to the IRS regarding a change of company name from what was originally filed.

- 2) Can you also please advise if I should register a "fictitious name". I am aware of the legislation, but am unclear as to the precise interpretation. Generally, we would wish market ourselves simply as "FlightPro" or "FlightPro Aviation Training"

in both the UK and the US. However, when used in context with descriptive phrases such as "professional ground training" or "Florida", it would seem that the number of variations is quite considerable. Would we need to register each and every one?

For example, I might say, "FlightPro Aviation Training currently offers professional ground training course only", or "FlightPro Professional Ground Training is the best Theoretical Knowledge Training you can buy", or "Please contact FlightPro Florida for further information".

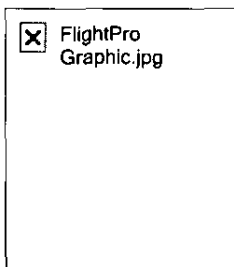
You will note that our logo carries the tag-line "professional ground training", and the addresses have "FlightPro Florida" and "FlightPro UK". These are all merely descriptive terms of what we do and our location, however to ensure that we are fully compliant with Florida legislation, please advise if anything within these contexts, might constitute the use of a fictitious name and require separate registration? If we were to simply drop the use of the "inc." at the end of our name, does that in itself make the name fictitious given that the full name appears on all financial and legal instruments?
