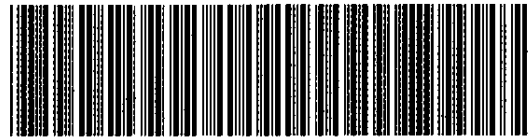

ARTICLE I NAME

The name of this corporation is PEPPERMINT REINDEER, INC.

ARTICLE II ADDRESS

The corporation's address is 1208 E. Kennedy Boulevard, Unit 729E, Tampa, Florida 33602.

ARTICLE III COMMENCEMENT OF CORPORATE EXISTENCE

The corporation's existence will commence July 21, 2010; provided however, that such date is within five business days prior to the date these Articles of Incorporation are filed by the Department of State of the State of Florida. The following individual will be the initial director of the corporation:

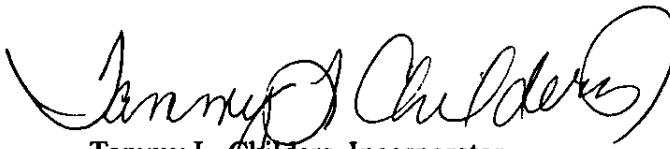

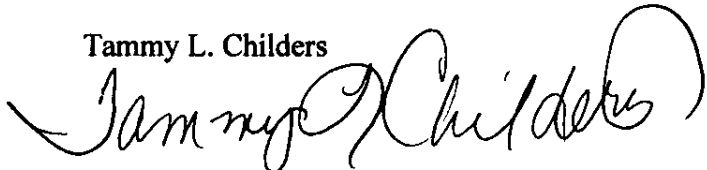
