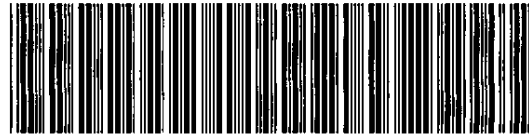

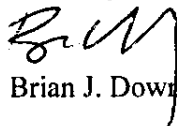

**ARTICLES OF INCORPORATION**

**ARTICLE I**

**NAME AND ADDRESS**

The name of this corporation is GETPONTOONSTUFF.COM, Inc. and its principal address is 14601 Bald Eagle Drive, Fort Myers, Florida 33912 and its mailing address is 14601 Bald Eagle Drive, Fort Myers, Florida 33912.

**ARTICLE II**

**DURATION**

This corporation shall exist perpetually commencing on the date of execution of these Articles of Incorporation.

**ARTICLE III**

**CAPITAL STOCK**

### INDEMNIFICATION

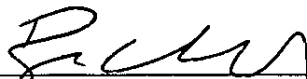

### AMENDMENT

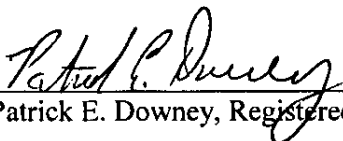
This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment to them by a majority vote of the shareholders.
