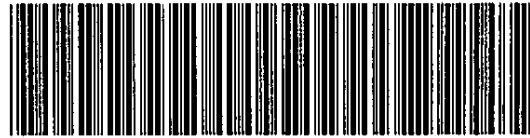

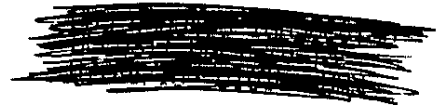

**Articles of Incorporation
Of

First: The name of this corporation is:
Palm Coast Media, Inc.

Second: The initial principal office and mailing address of this corporation will be at: 5797 Parkstone Crossing Drive, Jacksonville, Florida, 32258.

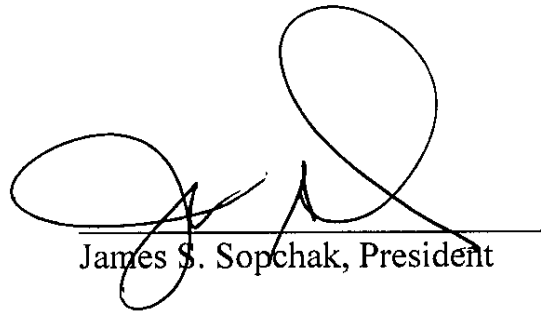

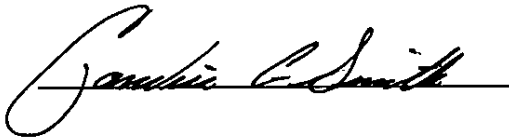

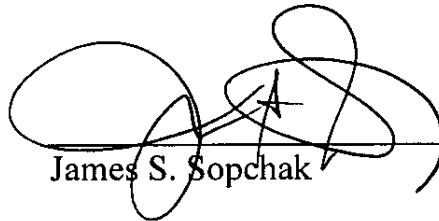
