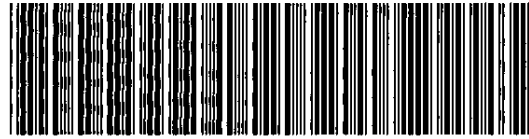

INDEMNIFICATION






