ARTICLES OF INCORPORATION OF
NOAS CORP.

The undersigned Incorporator, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation is NOAS CORP. (the "Corporation").

ARTICLE II. PRINCIPAL OFFICE AND MAILING ADDRESS

The address of the Corporation's principal office and the Corporation's mailing address are c/o One Biscayne Tower, 2 South Biscayne Boulevard, Suite 1500, Miami, Florida 33131.

ARTICLE III. DURATION AND COMMENCEMENT OF CORPORATE EXISTENCE

The Corporation shall exist perpetually. The corporate existence shall commence upon the filing of these Articles of Incorporation with the Department of State.

ARTICLE IV. NATURE OF BUSINESS

This Corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE V. CAPITAL STOCK

The Corporation is authorized to have outstanding one class of stock, to be designated as common stock ("Common Stock"). The maximum number of shares of Common Stock which the Corporation is authorized to have outstanding is 1,000,000 shares of Common Stock of a par value of \$.01 per share. Holders of Common Stock are entitled to vote on all questions required by law on the basis of one vote per share and there shall be no cumulative voting. Holders of Common

Stock shall have pre-emptive rights to subscribe to the Corporation's securities and are entitled to receive the net assets of the Corporation upon dissolution.

ARTICLE VI. OFFICERS AND DIRECTORS
