

**ARTICLES OF INCORPORATION

The undersigned Incorporator to these Articles of Incorporation, a natural person, competent to contract, does hereby form a corporation for profit under the laws of the State of Florida.

**ARTICLE I. CORPORATE NAME**

The name of this corporation shall be VILLAMOR ASSOCIATES, INC.

**ARTICLE II. INITIAL PRINCIPAL OFFICE**

The street address, and the mailing address of the initial principal office of the Corporation is: 8 Cousineau Rd., Pensacola, Florida 32507.

**ARTICLE III. CAPITAL STOCK**

The number of shares the corporation is authorized to issue is 10,000. No preemptive rights are to be granted to shareholders.

**ARTICLE IV. REGISTERED OFFICE AND INITIAL REGISTERED AGENT**

This corporation shall have perpetual existence, commencing upon the filing of these Articles.


**ARTICLE X. OFFICERS**
