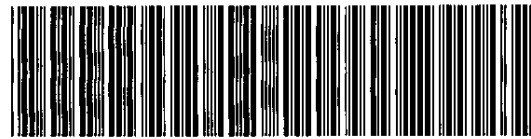

ARTICLES OF INCORPORATION  
OF  
ALL SMILES DENTAL ARTS, INC.

A Florida Corporation

ARTICLE I  
NAME

The name of the corporation is All Smiles Dental Arts, Inc.
