TO
ARTICLES OF INCORPORATION
OF
ADFONIC INC.**

Pursuant to the provisions of Chapter 607, Florida Statutes, Adfonic Inc. "Corporation") has adopted the following Articles of Amendment to its Articles of Incorporation.

FIRST: The name of the Corporation is Adfonic Inc. The document number assigned by the Florida Department of State is P10000064505.

SECOND: The following amendment to the Articles of Incorporation was adopted by the Corporation:

"Article I, in its entirety, of the Articles of Incorporation of the Corporation be and hereby is revoked and, in lieu thereof, the following article is adopted, approved and ratified:

**ARTICLE I
NAME**

The name of the Corporation is "Byyd Tech Inc."

THIRD: This Amendment shall be effective upon filing with the Florida Department of State.

FOURTH: The foregoing amendment was approved and adopted by the unanimous written consent of the directors and sole shareholder of the Corporation pursuant to F.S. 607.0821 and 607.0704 as of the 7th day of March, 2014.
