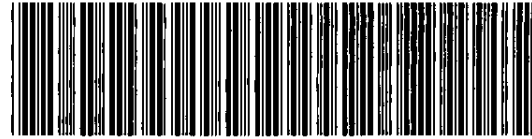


Sir or Madam:
