ARTICLES OF INCORPORATION OF: BLUE WAY, CORP.

The undersigned subscriber to these Articles of Incorporation a Natural Person competent to contract and hereby form Corporation for profit under Chapter 607 of the Florida Statutes.

ARTICLE I - NAME

ARTICLE VII AMENDMENT

These articles of Incorporation may be amended in the manner provided by law. ARTICLE IX POWER OF CORPORATION
