ARTICLES OF INCORPORATION OF MATO COMMERCIAL, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporations Act, hereby adopts the following Articles of Incorporation:

ARTICLE I

The name of the corporation, which shall hereinafter be referred to as the "Corporation" shall be: MATO COMMERCIAL, INC.
