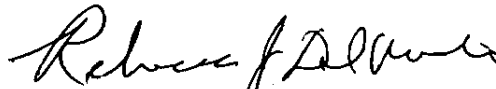

Article I Name

The name of this corporation is Twisted Logic Computing Corporation

Article II Principal Address

2629 Cherry Street
Denver, Colorado 80207

Article III Commencement

This corporation shall commence on the date of the filing of these Articles.

Article IV Purpose

This corporation is organized for the purpose of transacting any or all lawful business.

Article V Capital Stock

This corporation is authorized to issue 50,000,000 shares of \$.001 par value, common stock and 10,000,000 shares of \$.001 Par value, Preferred Stock, the rights, and preferences of which shall be established by the corporation's Board of Directors.

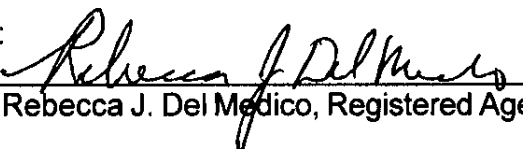
