ARTICLE I

NAME AND PRINCIPAL PLACE OFFICE

The name of the corporation shall be TILKYNAGY INTERNATIONAL, INC., and its principal office and mailing address shall be located at 9859 66th Street North, Pinellas Park, Florida 33782, but it shall have the power and authority to establish branch offices at any other place of places as the members may designate.

ARTICLE II

PURPOSES AND POWERS

5. To enter into and make all necessary contracts for its business with any person, entity,

partnership, association, corporation, domestic or foreign, or of any domestic or foreign state, government

or governmental authority, or of any political or administrative subdivision, or department, and to

perform and carry out, assign, cancel, or rescind any of such contracts.

To exercise all or any of the corporate powers and to carry out all or any of the purposes

enumerated in these Articles and otherwise granted or permitted by law, while acting as agent, nominee,

or attorney-in-fact for any persons or corporations, and perform any service under contract or otherwise

for any corporation, joint stock company, association, partnership, firm syndicate, individual, or other
